And this assurance of Safety is not by accident but by design, with a systematic & scientific approach to risk management in aviation. **Traditionally** aviation safety programs were reactive and factors contributing to an incident were attributed to either technical or human. This has however evolved over the last few decades where organisational factors are the primary contributor to all the aviation incidents. With this shift, regulators are promoting a more proactive approach to establishing a safety culture.

The airport eco-system is complex with multiple stakeholders from different domains because of

which effective implementation of SMS and managing regulatory compliance is a challenge.

AviatorSMS is a powerful tool that enables organisations to collect comprehensive incident data, create an accurate picture of the event, identify root causes and learning points, and implement corrective actions. It also helps the organisations to meet regulatory requirements as specified by ICAO/IATA or the State Civil Aviation Authority.

Safety is all about managing Risk.

According to ICAO, Risk Management is "The identification, analysis and elimination or mitigation to an acceptable level of those hazards and subsequent risks that threaten the viability of an organisation."

There are more than 600 lost opportunities to capture possible hazards before an incident occur.

The more hazards that are captured the less likelihood of an incident.

AviatorSMS has modules to capture hazards before they turn out to be incidents. It identifies hazards and systematically analyses risks and actions to mitigate the consequences. A fully customizable Risk matrix allows organisations to adapt to their own risk level.


